- Mentoring a part-time intern (1 day per week): 1 APC renewal credit per semester, limited to three credits per renewal cycle.
- Mentoring a full-time intern: 3 APC renewal credits per semester, limited to three credits per renewal cycle.
- Site Coordinator for a PDS: 3 APC renewal credits per year, limited to three credits per renewal cycle.

- Mentoring a full-time intern: 1 APC renewal credit, maximum of 3 in a 5-year renewal cycle.
- Site Coordinator for a PDS: 1 APC renewal credit, maximum of 3 in a 5-year renewal cycle.

- Mentoring a full-time intern: 3 APC renewal credits, maximum of 3 credits per renewal cycle. (See Note)

- Site Coordinator for a PDS: (MSDE/CPD #16-00-01) A maximum of 3 credits may be earned during a certification period by submitting a reflection log describing experiences and skills used while serving as a site coordinator. See Brian Phillips for specific criteria, performance outcomes and evaluation process. (See Note.)
- **Note:** A teacher who serves as both a site coordinator and a mentor teacher during the same certification period may only acquire credits for both opportunities during the same certification period one-time during their work history with Worcester County Public Schools.
