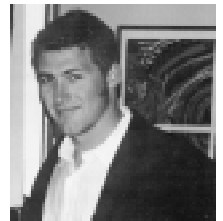

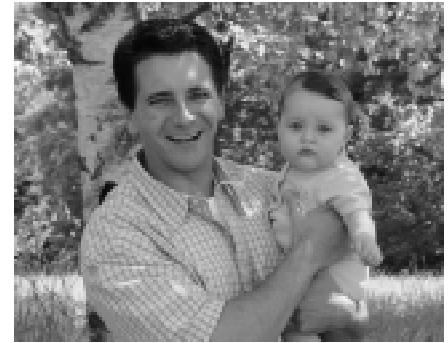

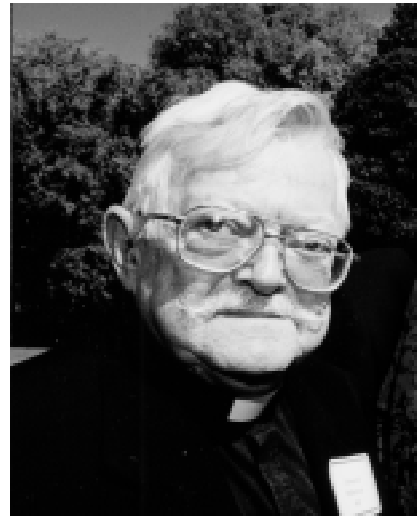
Faculty Death

Alethea Helen Whitney passed away Thursday, May 2, 2002. Ms. Whitney began to teach at Children's Home (FL) and continued to teach at various other schools until eventually coming to Salisbury University, where she began a 25-year career. She served as professor and head of the Physical Education Department and was one of the first women in the country to head both the women's and men's divisions of this department.

Edward H. Nabb

Edward H. Nabb Sr. died Sunday, June 2, 2002. Mr. Nabb was a prominent Cambridge attorney who became a partner and a partial owner of the Law Offices of Harrington, Harrington and Nabb after extensive self-education. He presented Salisbury University with an endowment for the Edward H. Nabb Research Center, a center for genealogical research, in 1998 and also served as president of Dorchester County's Nathan Foundation for more than 20 years. He was presented with a Doctorate of Humane Letters from Salisbury University in 1999 for his lifetime of service.

Edward F. Holloway



Edward Francis Holloway '49 was born October 11, 1926, in Salisbury, MD, the youngest of seven children born to Dr. William J. Holloway, the founder of Salisbury State Normal School, now Salisbury University. After serving in the Army, he returned to Salisbury State and became an exemplary student.

He met Jacquelyn Sturgis, also a student at Salisbury State, while he was working at Johnny's and Sammy's, a local diner. They married on July 8, 1949, at the end of her junior year. Jackie never returned to college as she soon learned she was pregnant with their daughter, Constance Marie Holloway.

Edward did his graduate work at University of Maryland and University of Delaware and was a teacher/principal in the Wicomico County public school system until 1961. That year the family moved to

Gambier, OH, where Edward entered Bexley Hall at Kenyon College to become an Episcopal priest. In 1964 Father Holloway received a

Master's of Theology there. He then took a headmaster position in Boynton Beach, FL, at St. Joseph's. In 1967 the family moved to Daytona Beach where he became headmaster of St. James Day School. Jackie taught fifth grade at St. James until her death from cancer in March 1984.

In December 1984, Father Holloway married Kandy Lowe, a widow whose son had attended St. James. Soon after, Father left St. James and became vicar at St. Timothy's. He held that position for five years and then became assistant priest at St. Mary's Episcopal Church, a position he held until his death. He died on July 7, 2002, after being hospitalized for five days for complications from emphysema.

Richard A. Henson

Richard A. "Dick" Henson died Wednesday, June 12, 2002. In his earlier years, he started the Henson Flying Service in Hagerstown, MD, and became the chief executive officer of his company by the age of 21. Mr. Henson was one of the first to be given a contract to train future instructors for the military during World War II. In 1987, he gave Salisbury University's school of science a generous

endowment, which led to the creation of the Henson School of Science and Technology. Along with other accomplishments, Mr. Henson also established the Richard A. Henson Foundation for educational institutions and community services, through which he made several generous contributions to organizations on the Lower Eastern Shore.
