Call to order: 3:30 pm

1. Announcements from President Lepre's proxy, Chief of Staff Eli Modlin
 - a. Q: Is Enrollment Management's move to the President's Office permanent?
A: No plan to move it again
 - b. Q: Why didn't HR didn't send out the sad news email, and what are the reasons that the SU community no longer has access to email lists? A: Accessibility, standardized formatting, volume of emails, cybersecurity – prevents problems in case of hacking/phishing. Emails can still go out after going through the [Digital Strategy Support Center](#) ticketing system or contact Jessica Clark for things that make sense to go to all faculty.
 - i. Follow up: Is there a way to make it so faculty can easily email each other? A: Will bring up with Jessica Clark and Ken Kundell
 - c. Q: Can you tell us more about the recently announced Board of Visitors? A: Advisory board without statutory authority – designed to provide advice, share expertise, and serve as university ambassadors and champions. Majority of USM campuses have Boards of Visitors, governed by [USM I-4.00 Policy on USM and Institutional Boards and Commissions](#). Looking for folks across the bridge and around the region. Tentative early spring launch.
 - i. Q: Will this Board participate in strategic planning and community spots on committees? A: In the future, likely yes
 - ii. Q: Where will info be housed on this Board? A: TBD, likely webpage under President's Office or Public Affairs
 - iii. Q: How many people? A: 13-15
 - iv. Q: Will they have any impact on curriculum or hiring? A: No
 - v. Q: Are these paid positions? A: No
 - d. Q: Since we don't have a Registrar at the moment, what is the plan to redistribute the workload or hire for this position? A: Associate Registrar Liz Kressin is current point of contact, Eli will follow up on future plan
 - e. Q: Why were faculty not consulted in the recent change regarding athletes being able to register first? Concerns that athletes will bump students who need a course for their major or that we're prioritizing athletics over

academics. A: Athletes have severe schedule constraints with set practice and travel times. This moved a little faster than expected, apologies

- f. Q: Has the government shutdown affected student veterans? A: The shoe hasn't necessarily dropped yet but Administration is preparing. Working with specific populations related to fees and payment; we may see an increased stress on resources such as Food for the Flock and Counseling Center; discussions are happening related to potential financial support, Foundation and otherwise; Eli will follow up on how admin is prepping support services.
 - g. Q: Is there any news related to [Compact with Higher Education](#)? A: System is taking the lead, university Presidents have been meeting

 - iv. Aurora Edenhart-Pepe has been responsive and is working with FFOC
