SUBJECT: Announcing Sabbatical Decisions Earlier

SENATOR PROPOSING MOTION: Anita Brown

MOTION (this section alone will be recorded in the minutes):

Item 3 of the Procedures section in the Sabbatical Leave for Faculty and Professional and/or Research Leave for Faculty Members Engaged Exclusively or Primarily in Library Services in Chapter 3: Faculty Leave of the SU Faculty Handbook shall be altered as shown below.

3. Applications for sabbatical or professional and/or research leave are recommended or not recommended or recommended for resubmission by the Provost and approved or disapproved by the President of the University by ~~January 31~~ January 15 for fall sabbatical leaves and ~~August 31~~ June 15 for spring sabbatical leaves. The President of the University then notifies applicants, their chair/director/supervisor, and their dean. The Provost may recommend an application for resubmission when the number of applications results in worthy sabbatical applications being denied. These applicants should be encouraged to apply again.

JUSTIFICATION:

The current notification dates for sabbaticals (January 31 for fall leaves and August 31 for spring leaves) make it difficult for departments/schools, and the faculty applicant to appropriately schedule. Department chairs/schools often must have created the schedule for the upcoming semester without knowing if the faculty applicant will be on sabbatical or not. For example, schedules for the upcoming fall semester are often completed in January but sabbatical applications for the upcoming fall semester are not announced until Jan 31. Hence department chairs/school directors often must actually juggle multiple plans so that if it turns out a faculty member is awarded a sabbatical, the schedule may be adjusted. If sabbatical awards could be known before schedules are prepared in January, the workload of department chairs/school directors might be slightly improved.

The proposed earlier announcement dates for awarding of sabbaticals will provide more planning time for department chairs/school directors as well as for the faculty members applying for sabbaticals.

ANTICIPATED IMPACT:

Negative:

The Provost and the President will have less time to make decisions regarding sabbaticals.

If, as in past, when financial shortfalls cause the Provost or President to propose to limit the number of sabbaticals awarded, it could be that sabbatical announcements have been made before the financial shortfall is known.

Positive:

Department chairs/school directors will more likely know whether a faculty member will be on sabbatical during a semester when they are planning and submitting schedules for that semester. Faculty members applying for sabbatical leave will also know earlier whether they will be awarded a sabbatical and hence have more planning time.
