 - a. Employee Meal Plans Owen:
 - i. The feasibility of an employee meal plan was discussed.
 - 1. Promote more staff to stay on campus to eat
 - 2. Must be isolated from student plans
 - a. HR benefit of employment
 - i. For SU Faculty and Staff
 - ii. Run by fiscal year with payroll deduction or pay up front
 - b. Managed much like parking services
 - c. Need configuration for 12-month FY or CY; not semester based
 - d. Cost will be at least \$8/meal
 - i. Sold in blocks of 25 meals
 - ii. \$200 per block
 - e. Strictly to be used in the Commons
 - i. No satellite dining (dining dollars)
 - ii. Trial
 - iii. No meal sharing; 1-meal per day
 - iv. Use it or loose it; unused balance will not carry forward
 - b. HR Committee: met on 12/14
 - i. Daycare on hold not moving forward at this time
 - ii. 2 ½% probationary increase discussed;
 - 1. Not always consistently applied.
 - 2. Internal candidates ARE eligible for 2 ½% increase upon success probationary period. Confirmed by Kevin Vedder will be retroactive for those that did not receive their increase.
 - iii. Would like GullNet to identify if employees are included in the bargaining unit.
 - 1. Individual GullNet accounts
 - 2. Working with Patti Turpin
