Application Process for Summer Pell Grants & Direct Loans

- 1. Carefully read the Pell and Direct Loan Eligibility Criteria below.
2. If you are on Financial Aid Satisfactory Academic Progress and/or Academic Affairs Termination or Probation status, your eligibility will be determined at the conclusion of the spring 2015 semester.
3. If you change your total summer enrollment after you submit your application(s), it can reduce or cancel your aid and increase your remaining charges. You are responsible for contacting our office, immediately, with all enrollment changes.
4. The Return of Title IV funds policy applies to students who withdraw officially or unofficially from all summer courses.
5. If your summer aid exceeds your summer charges the Cashier's Office will process a refund.
6. You are not permitted to receive federal/state financial aid at two different institutions simultaneously.

Summer Pell Grant Eligibility Criteria

- If you are eligible for Pell funds based on your 2014-15 FAFSA data, and you did not attend full-time for fall 2014 or spring 2015, then you may be eligible for summer Pell funds based on your leftover fall 2014 or spring 2015 Pell funds. No action is needed on your part. Our office will determine eligibility based on your enrollment.

Summer Direct Stafford Student Loan Eligibility Criteria

- Enrolled in at least 6 credits (half-time)
Loan eligibility is calculated based on any unused Stafford loans that are remaining from the 2014-2015 academic year.
If you drop to below half-time during the summer session(s), your loan eligibility will be terminated and you will be responsible for any bill received as a result.
We will automatically offer the maximum amount for which you are eligible to receive.

Summer Parent PLUS Loan Eligibility Criteria

- Enroll in at least 6 credits (half-time)
If your child drops to below half-time during the summer session(s), your loan eligibility will be terminated and you will be responsible for any bill received as a result.

Summer Graduate Student Loan Eligibility Criteria

- Enroll at least half-time
Have the 2014-2015 FAFSA on file at SU.
