



**FEDERAL DIRECT PLUS LOAN INFORMATION FORM 2016-17**

The Federal Direct Parent's Loan for Undergraduate Student (PLUS) allows parents to borrow on behalf of their child. The U.S. Department of Education Direct Loan Servicing Center will conduct a credit check on the parent borrower before approving the loan. If the loan is denied because of an adverse credit history, the Servicing Center will notify the parent. In this event, the dependent student may apply for an additional Unsubsidized Federal Direct Student Loan.

The amount of the Plus Loan shown on the Financial Aid Notification is the difference between the cost of attendance and any financial aid for which the student is eligible. If the student receives an additional resource, or if the student's enrollment or academic standing changes at any time during the year, the university may reduce the PLUS Loan.

**NOTE: ONLY ONE PARENT SHOULD COMPLETE THIS APPLICATION - The applicant must be the student's biological or adoptive mother or father. A stepparent is also eligible to borrow if his/her financial information is reported on the FAFSA.**
