### Higher Education Emergency Relief Fund (HEERF)

#### Institutional Portion

Salisbury University (SU) signed and submitted a Certification and Agreement to the US Department of Education on April 21, 2020, requesting funds from the Higher Education Emergency Relief Fund. SU received \$5,959,457, and will distribute one-half (\$2,979,729) directly to students in the form of Emergency Financial Aid Grants. The remaining \$2,979,728 will be used to support the Institution for expenses incurred as a result of the COVID 19 Pandemic.

Per the guidelines issued by the United States Department of Education, funds can be used to reimburse institutions if they offered refunds to students who were not able to return to campus due to the Pandemic. Beginning on Friday, March 27, Salisbury University began issuing refunds of approximately 53% of SU Meal Plans, Housing charges and SU Mandatory Fees. Students were refunded 21% of parking permit cost. The CARES Act funding was used to offset those refunds.
